




# Every child deserves a strong start

# The Challenge


Across the nation, child poverty continues to be a pressing issue. In 2019, over 70 percent of counties had a child poverty rate that exceeded the national average.



# The Opportunity

Counties are front line service providers. Each year, counties invest \$62.8 billion to serve as a safety net for millions of residents and deliver vital services to our nation's most vulnerable populations.

Counties are prioritizing prenatal-to-three in COVID-19 recovery efforts. NACo's analysis of 200 county ARPA Recovery Fund plans found that 68 percent of these plans include investments in human services, children and families.
